- **M_Steven Polansky -- MD, FACOG** does not openly advertise that he does abortions. He is an owner of the Camellia Women's Health Clinics located in Sacramento, Carmichael and Roseville. He has hospital practice privileges at Mercy San Juan Hospital and Sutter Hospital.



Our investigation disclosed that Polansky performs most of his abortions at his clinic located at the Sacramento Surgery Center. Pictured at right is Polansky photo and another of him driving away from the Roseville Planned Parenthood. At least two other physicians working with Polansky at Camellia, **Marvin Kamras, MD, FACOG**, seen above and **Lisa Sundberg, MD, FACOG**, far right. These two abortionists also have hospital practice privileges at Marcy San Juan Hospital. Polansky's Carmichael office is utilized by significant numbers of the Slavic community, most of whom do not know that these doctors do abortions. We will be identifying additional abortionists in coming issues, again asking you to pray for their conversion and the cessation of their slaying of the pre-born babies.

Catholic Hospital?

Beginning in May, June and July of 2009, this newsletter made known that Mercy San Juan Hospital was employing and endorsing identified abortion doctors, specifically the three above named abortionists. I reported that I had made this known to Bishop Soto by letter and the Bishop's Respect Life Coordinator, Kathy Connor. I also reported my meeting with MSJH hospital officials, resulting in indifference and inaction. In fact, we learned that MSJH even does tubal ligations. I also exposed the fact that Llyodd Dean, highly paid head of Catholic Healthcare West (recently identified as 9 million per year), was a big supporter of Barak Obama and his plan for nationalized healthcare which endorsed abortion coverage. Local Catholics wrote to the Bishop and the hospital with negative results. I had to let it go as I, being an evangelical Christian, apparently had no influence with the Catholic Bishop.

National news has now revealed what my story revealed much earlier. We hope all of you good Catholics will ask to speak personally with Bishop Soto. I am now hearing that letters to the Bishop are being ignored. It may be time for a presence and public protest with signs and press coverage to let the public and the Bishop know that action is required. The Bishop of Arizona, a man of God who is willing to follow Catholic directives, removed the Catholic name from St. Joseph's Hospital in Arizona after

learning that the hospital had ignored Catholic directives. All good Catholics in the Sacramento area should urge Bishop Soto to do the right thing and demand that abortion doctors be removed from working at MSJH or remove the name Catholic from the hospital.
